## Creating Homes

DRCC is in the process of developing two new homes, one in Hermantown and one in Virginia. This is an exciting (and somewhat anxious) time for everyone involved; individuals, their families, case managers, and our staff. Developing a new home presents us with an opportunity to create something new and wonderful for individuals and their families.

Exactly how do you go about creating a home? We all have a vision of what a home should be. For most people this vision includes a place where we are both physically and emotionally comfortable, where we are loved, where we can get recharged, where we are with people we like, where we can do things we like, and where we can safely keep our important "stuff".

Many people are involved in taking the vision and making it become reality. It starts with families and individuals conveying their hopes and dreams to those of us with the responsibility for carrying it out. Each step along the way is important – from finding the right roommates, to finding the right home, to selecting the right staff. Inevitably, there are a few bumps and hurdles along the way and we have to work together to successfully navigate them. Our goal is to have both new homes ready for everyone to move in between mid-January and mid- February 2004.

## Fairview

The Fairview home is located at 306 North 14<sup>1</sup>/<sub>2</sub> Circle in Virginia. Four women will share this two-story home. Three of the four women are currently living with their families and are excited to take this next step. The fourth woman is living in an adult foster setting and is looking forward to a new home.

The women are looking forward to sharing a house with their roommates and having the opportunity to learn a variety of new skills. Fairview promises to be a very active home with good participation in a variety of community activities.

## Bishop Woods

The Bishop Woods home will be located at 4816 Oak Ridge Drive in Hermantown. For only the second time in its history, DRCC is designing and building this home. Four children who have significant physical and medical needs will share this new home. An additional bedroom has been incorporated into the design so the home will be able to provide short-term respite for one additional child when a family needs respite.

Accessibility and spaciousness guided the design of the home. Each child will have their own bedroom with plenty of space for their medical equipment and personal belongings. The home will have two whirlpool tubs, an overhead lift system to aid with transferring, and spacious living areas for the children.

Staff will be available twenty-four hours a day to care for and support the children. The staff complement will include an RN, LPNs, and assistants.

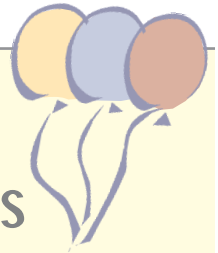


## TRIBUTE

On August 15th DRCC held its Fourth Annual "Golf with the Stars" fundraising event. All of the money raised is used to directly benefit individuals served by DRCC. This is particularly

important now, when some of the 2003 legislative changes have had a direct and significant impact on the personal spending money for a number of our clients and families. Effective October 1st, individuals are charged co-payments for their doctor visits and prescriptions. For most of the individuals we serve the co-payments are modest and will have a minor impact. However, for a small group of individuals, who have many

medications and frequent doctor visits, the impact is dramatic. DRCC plans to use a portion of the golf proceeds to help soften the impact for these individuals.

We want to thank everyone who contributed to this fundraiser. The event's success would not have been possible without the generous support from all the sponsors, contributors, and those who participated.
